Thank you for your request for Kosher certification.

In order to process your application, there is a non-refundable application fee of \$500.00 plus \$25.00 G.S.T. and \$39.38 Q.S.T. A cheque in the total amount of \$564.38, should be made payable to the Jewish Community Council of Montreal.

A complete list of all products and the respective ingredients and raw material used in their production and processing, detailing names and addresses of suppliers and manufacturers, must be submitted to us, for which purpose we are enclosing an ingredient form. The Jewish Community Council/Vaad Ha'ier is not interested in the formulation, but only in the materials per se and naturally this information is treated as highly confidential.

* Products, ingredients or raw materials from both local and overseas suppliers should be accompanied for by Kosher Certificates from authorized Rabbinate where available. Should any of the contents not meet with kosher approval, we will endeavor to advise you of alternatives. When these have been approved, an inspection of your plant will be carried out.

Please also submit a full floor plan for your plant.

Prior to the issuing of Kosher Certification, an agreement must be signed by both parties to formalize arrangements, copy of which will be forwarded to you.

Upon Kosher approval, we will list your company in our Kosher Guide which will be distributed both locally and overseas.

We would like to also draw to your attention that in terms of the agreement, the MK Kosher symbol must be included in your packaging material. This makes for clear identification for the Kosher consumer and it is specifically advantageous to the export market.
